Request for Child Daycare Information

The Momence Police Department is requesting any information on child day care service that you provide from your residence. We are seeking ways to help make our community safer and offer services for our residents. In order to improve our Sex Offender tracking and monitoring program we need your help. As you may know, there are many laws that help monitor sex offenders living in the area or attempting to move here. One of those laws is:

720 ILCS 5/11-9.4 (b-5): It is unlawful for a child sex offender to knowingly reside within 500 feet of a playground, child care institution, day care center, part day child care facility, day care home, group day care home, or a facility providing programs or services exclusively directed toward persons under 19 years of age.

This law protects those places listed by prohibiting child sex offenders from living within 500 feet of a residence that provides day care. With this in mind, we are asking for your cooperation in completing the information below that will help us to enforce those laws that keep our children safer and allow us to feel more secure in our own homes.
